Maryland Lawmakers Override Governor Hogan's Veto of HB1



Last Friday, January 12, Governor Hogan's veto of HB1 Labor and Employment - Maryland Healthy Working Families Act (2017's Paid Leave Law) was overridden and the legislation is currently scheduled to go into effect on February 11. This legislation impacts all businesses and nonprofits.

Since Friday, Governor Hogan issued an Executive Order creating the Office of Small Business Regulatory Assistance to assist small businesses in complying with HB1. The Maryland General Assembly has 50 days to consent or pass a resolution of disapproval. The Governor also introduced [HB98/SB135 - Paid Leave Compromise Act of 2018](#) this week.

A grant through the Maryland Department of Housing and Community Development's Main Street Improvement Program will provide for design, print, and install 70 lamppost banners from the Depot to Main Street, along Main Street from Grant Street to Water Street, and down Broadway and Water Street.

Grants Promote Economic Literacy Efforts

Dedicated to the goal of increasing economic literacy, grants will be provided to programs that address the following issues: raising public participation in economic education and creating a demand for greater economic literacy; encouraging measurement of economic understanding; developing the application of new strategies for teaching economics, helping those working in social service agencies, particularly social workers, provide financial and economic understanding; and helping disenfranchised youth or young adults with children learn to participate in the economic system.

The upcoming application deadline is Thursday, February 15, 2018.


