

The survey highlights the experiences of small businesses and provides critical information that service providers, policymakers, and lenders use to improve programs for small business owners.

The program is open to application from all institutions of higher education and associated organizations.



The Draft 2040 BPMP is a comprehensive document that outlines existing conditions-demographics, infrastructure, safety, regional overviews, accomplishments, and emerging themes-and identifies future goals, objectives, and strategies. Drawn from these strategies, key initiatives are listed, each including short- and long-term targets that address the needs and opportunities for proposed bicycle and pedestrian policies, planning, and infrastructure projects throughout the State of Maryland.
