### State Forest Annual Work Plans Public Comment Period

The Maryland Department of Natural Resources seeks public comment on the proposed 2021 fiscal year work plan for Potomac Garrett, Green Ridge, Savage River, Chesapeake and Pocomoke State Forests.

Annual work plans help identify priorities within the scope of the forest's long-range management plan. They address establishment, growth, composition, health and quality management operations, along with maintenance and construction projects, and other actions.

Following the conclusion of the comment period on **February 28, 2020** each forest manager will review, revise and finalize their plan.



