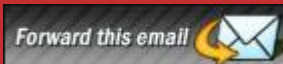
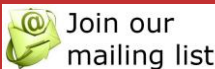
ARC Seeks Partner & Community Input to Guide Investment Priorities

Appalachian Regional Commission (ARC) is collecting input via a [public survey](#) to identify critical opportunities and challenges facing Appalachia's economic future for its new strategic plan for fiscal years 2021-2025.

ARC develops a new strategic plan every five years. More than 3,000 Appalachians provided input to develop ARC's current strategic plan, ***Investing in Appalachia's Future: The Appalachian Regional Commission's Five-Year Strategic Plan for Capitalizing on Appalachia's Opportunities, 2016-2020***, which expires on September 30, 2020.

"As we plan ARC's investment strategy for the years to come, it is important that we be informed by the people we serve," said ARC Federal Co-Chairman Tim Thomas.
